## **PFF Requirements**

Minimum Experience	5 years multi-modal experience
Background check	<ul> <li>Must be nominated by their employer</li> <li>Include proof of employment</li> <li>Two industry related references</li> </ul>
Participation and Maintenance	In order to maintain the PFF Designation a PFF must participate in at least one Industry-related event, and one educational event every year.
	<ul> <li>Proof of attendance required</li> <li>Some examples include:</li> <li>CIFFA AGM</li> <li>FIATA World Congress</li> <li>CIFFA Working Group (e.g. Air Cargo Security, PFF, etc.)</li> <li>Groups/committees (e.g. Transport Canada, Canadian Border Services Agency, etc.)</li> <li>Trade show attendance (e.g. IE Canada, CITA, TIACA, etc.)</li> <li>Continuous training (e.g. Dangerous Goods, Local Chamber of Commerce/Board of Trade seminars, etc.)</li> </ul>
Application process	<ul> <li>Applications can be completed once all requirements are met</li> <li>Applications are approved by the CIFFA board</li> </ul>
Education	<ul> <li>PFF's must complete the following educational requirements:</li> <li>CIFFA Certificate in International Freight Forwarding</li> <li>CIFFA Advanced Certificate in International Freight Forwarding or FIATA Diploma Course</li> <li>Three designated management courses created in partnership with the Schulich School of Business.         <ul> <li>Exemptions for these courses for current PFFs are listed below.</li> </ul> </li> <li>Completion of select CIFFA workshops         <ul> <li>CIFFA Standard Trading Conditions</li> <li>Business Ethics for the Logistics Professional</li> </ul> </li> </ul>
